Consulting Engineer:

An individual possessing the necessary qualifications to practice in one or more of the various branches of engineering who:

- a) As his principal occupation devotes himself either individually on his own account or as a partner, director or consultant of a firm of consulting engineers to advising the public on engineering matters or designing and supervising the construction of engineering works and;*
- b) For such purpose occupies his own office employs his own staff or in the case of a partner, director or consultant of a firm of consulting engineers uses the office and staff of the said firm and has no direct or indirect concern or interest in any commercial or manufacturing or contracting business such as would tend to influence his exercise of an independent professional judgement in the class of work in which he or his firm engages.*

Consultant:

An individual required in a consulting capacity by one or more consulting engineers either having himself formerly been a consulting engineer, otherwise than as a consultant or (whether or not formerly a consulting engineer) for his particularly specialized or distinguished knowledge.
